Past Due Accounts: Sandhill Landscape Supplies, LLC reserves the right to charge 1.5% per month as a service charge on overdue accounts and unpaid balances or 18% per annum, but not to exceed the maximum amount permitted by applicable state law.

Cost of Collection and Attorney Fees: Customer and/or recipient, or their designated agent, who accepts goods or services provided by Sandhill Landscape Supplies, LLC or any of its affiliates or subsidiaries agrees that said goods and services were provided from the general office of Sandhill Landscape Supplies, LLC located in Moore County, North Carolina, and that the proper venue for any legal action relating to the provision of said goods and services is in More County, North Carolina, including Magisterial District 052. Customer agrees to pay the full amount of any costs or expenses.

Sales Tax: All Sandhill Landscape Supplies, LLC customers must be exempt from sales tax. Please send completed sales tax exemption certificate.

Timely Notification: No shipping or delivery claims will be accepted unless made within 10 days of receipt of merchandise. All buyer claims resulting from incorrect invoicing must be submitted to Sandhill Landscape Supplies, LLC in writing within 60 days of invoice date, or Sandhill Landscape Supplies, LLC agrees to accept invoice as billed. Sandhill Landscape Supplies, LLC will not make adjustments for claims after 60 days from invoice date.

Authority of Parties: No soliciting agent, sales representative, or employees of Sandhill Landscape Supplies, LLC shall have the power to waive any of the terms or provisions hereof, or to incur additional obligations, or to make additional representatives or warranties on behalf of Sandhill Landscape Supplies, LLC unless same are evidenced by an agreement, in writing, signed by a duly authorized officer of Sandhill Landscape Supplies, LLC or credit manager. Signer of buyer represents that he is a duly authorized agent for the buyer, empowered to sign this document and that the information supplied on the Credit Agreement form is true and accurate.

Governing Law: This agreement shall be governed by the laws of the State of North Carolina.

Conditions: The account established hereunder and the credit extended hereby shall not be effective until this application is accepted by Sandhill Landscape Supplies, LLC in Southern Pines, NC. Buyer represents that this account is for business use only and that the buyer will not purchase products from Sandhill Landscape Supplies, LLC hereunder for personal, family, agricultural or household use.
